## INTRODUCTION

As part of the key objective of the Securing Nigeria Communities project, Equal Access International, led by the Country Director Dr. Maji Peterx, in company with Lawyers Alert the local resource organization (LRO) paid a courtesy visit to the newly appointed transition Charman of Gwer-west LGA **Hon. HENRY AGBA**, to discuss about the early warning and early response mechanism. (EWER system) initiated in the LGA that ensures women and youths inclusion in the security architecture of the community. The country Director congratulated him on his appointment and reiterated the gains and cooperation maintained with the out-going chairman who ironically was also the chairman of the Community Accountability Forum (CAF) put together by EAI to be the response platform for early warning signals from the wards, manned by a sister platform, the Civilian Accountability Platform.
